### **Annual Garage Sale**


The Fox Hollow/Edenbridge garage sale is currently scheduled for **Friday May 19 & Saturday May 20.**


### **You Could Have the Yard of the Month!**

## Pufferbelly Trail Extension

Work has begun on the Pufferbelly Trail from Life Bridge Church to Fitch Road. This means the entire corridor will be closed, including the natural surface areas that have become very popular over the past few years. We ask that you please stay off the trail during the construction process. This is for everyone's safety and will also help minimize delays. In the meantime, you are invited to walk the trails in Payton County Park off of Dunton Rd. just north of Hathaway Rd. The parking lot and many of the trails have been paved. It will connect with the Pufferbelly Trail when it's completed, scheduled by the end of summer 2023.

## Get Out That Green Thumb!

As the Association has been turned over for some time now, it is the Board's responsibility in making sure all Covenants are followed by all the residents accordingly. One specific Covenant requirement the Board will be addressing this season is *landscaping*. All lots must have their lawn and sufficient landscaping installed *as stated by their specific section of the Covenants*. Regular drive-throughs will be conducted when the weather improves. Our goal is to enhance neighborhood aesthetics and curb appeal. We have a beautiful neighborhood and want to keep it looking that way! If you did not submit landscaping plans and your house is deemed insufficient, you may be asked to provide plans for future landscaping enhancement. ## Let is Snow... NEXT YEAR!

As this winter season ends, here are some important points to remember about our snow removal policy and expectations:

- Plow trucks do not get dispatched until a 2-inch accumulation threshold is met.
- Streets should be cleared of parked cars or other obstructions when snow accumulation is projected.
- Please remain patient after a heavy snow fall - the time it takes before the plow trucks arrive to begin clearing the streets can vary widely from incident to incident as we're not their only clients.

The HOA maintains contact with the plow truck's operations department should any additional needs be recognized, such as salt, missed areas, or additional passes.
