TO DECLARATION AND PLANS OF AWB CONDOMINIUM

THIS AMENDMENT NO. 17 TO DECLARATION AND PLANS OF A WB CONDOMINIUM ("Amendment") is made by A WB Holdings LLC ("Declarant") as of June 14, 2018

WITNESSETH:

WHEREAS, Declarant is developer of A WB Condominium, having recorded Declaration of Condominium Ownership, By-Laws, Plans and Covenants in the office of the Recorder of Allen County, Indiana as Document Number 2012022148 and Plat Cabinet G, Page 38, as subsequently amended ("A WB Condominium Declarations"). The A WB Condominium Declarations and Amendments 1 – 16 thereto are incorporated herein by this reference; and

WHEREAS, the areas of Condominium Units 104, 105, 107, and 702 as set out in prior amendments to the A WB Condominium Declarations have been revised and, pursuant to the Indiana Condominium Act, the A WB Condominium Declarations must be amended to show the location, layout, and dimensions of said Condominium Units "as-built"; and

WHEREAS, the Usable Square Feet of the Building has been changed due to the incorporation of formerly common areas adjacent to Units 104 and 107 into those units and a revision of Unit 702.

NOW, THEREFORE, the A WB Condominium Declaration is amended as follows:

1. Declarant affirms that former Unit 105 has been subsumed into Unit 104, as has the common area between them. A restroom common area of 71 sq.ft. adjacent to Unit 107 has been subsumed into Unit 107. The amended site plan attached as Exhibit A accurately shows the location, layout and dimensions of Condominium Units 101, 104, and 107 as certified in the Architect's Verified Statement for Amendment No. 17 to A WB Condominium attached as Exhibit C to this Amendment and incorporated into and made a part of the Declaration. Note that the area of Unit 101 has not changed from prior amendments.

2. Declarant affirms that former Unit 702 has been divided into Units 702A and 702B. The amended site plan attached as Exhibit B accurately shows the location, layout and dimensions of Condominium Units 702A and 702B, as certified in the Architect's Verified Statement for Amendment No. 17 to A WB Condominium attached as Exhibit C to this Amendment and incorporated into and made a part of the Declaration. Note that the areas of Units 701, 704, 705, 706, and 707 have not changed from prior amendments.

3. Declarant affirms that the total Usable Square Footage of the Building is deemed to be 93,084 square feet, as set out per floor on Exhibit D to this Amendment and incorporated into and made a part of the A WB Condominium Declarations. For purposes of calculating the Percentage Interest (as defined in the Declaration) of each of the subject Condominium Units and Tracts, the area of the Building shall be deemed to be 93,084 square feet.

Unit 104 is deemed to be 8,346 square feet; (ii) Unit 107 is deemed to be 3,387 square feet; (iii) Unit 702A is deemed to be 642 square feet; and (iv) Unit 702B is deemed to be 220 square feet.

In all other respects, the A WB Condominium Declarations remain unchanged.

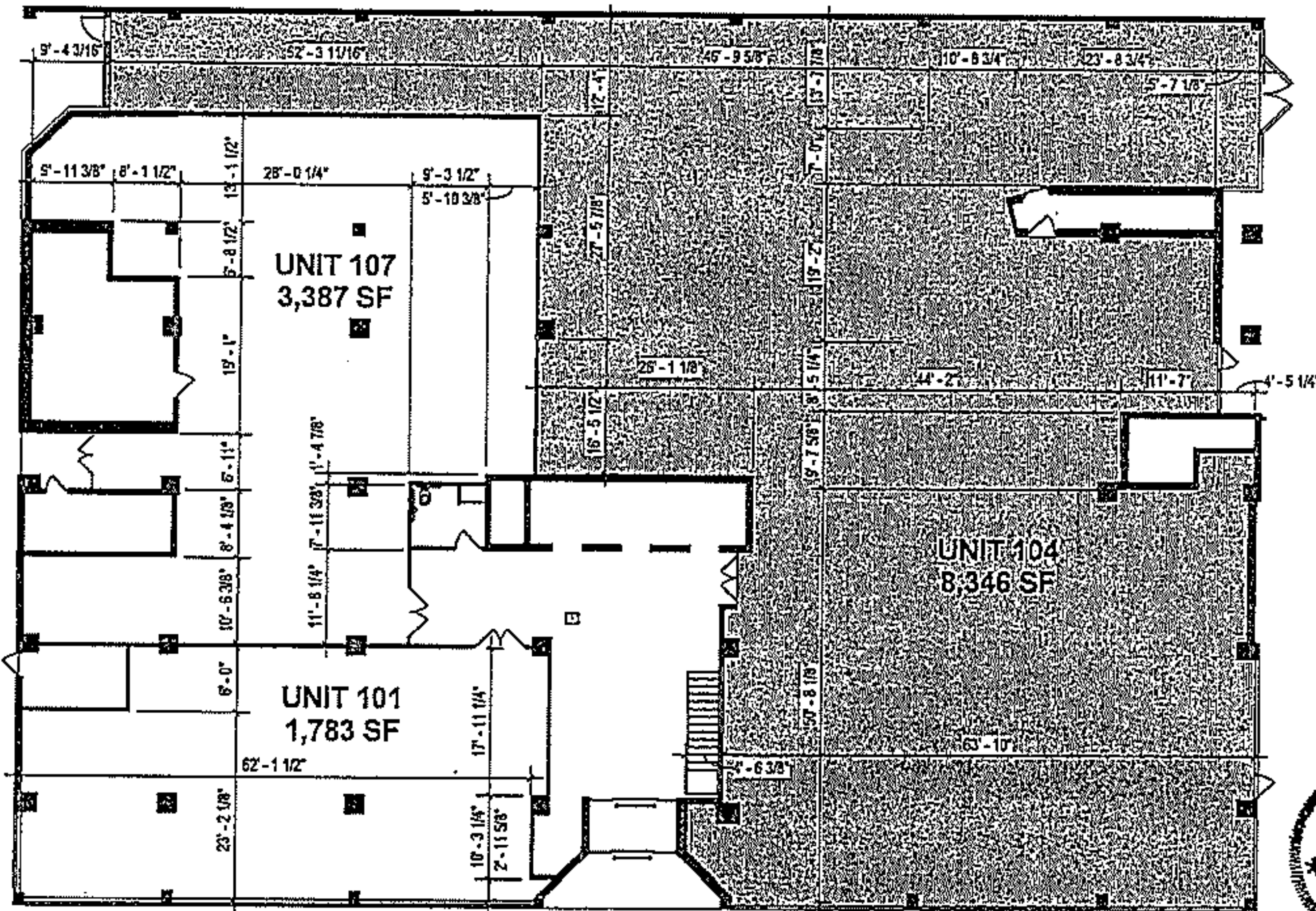

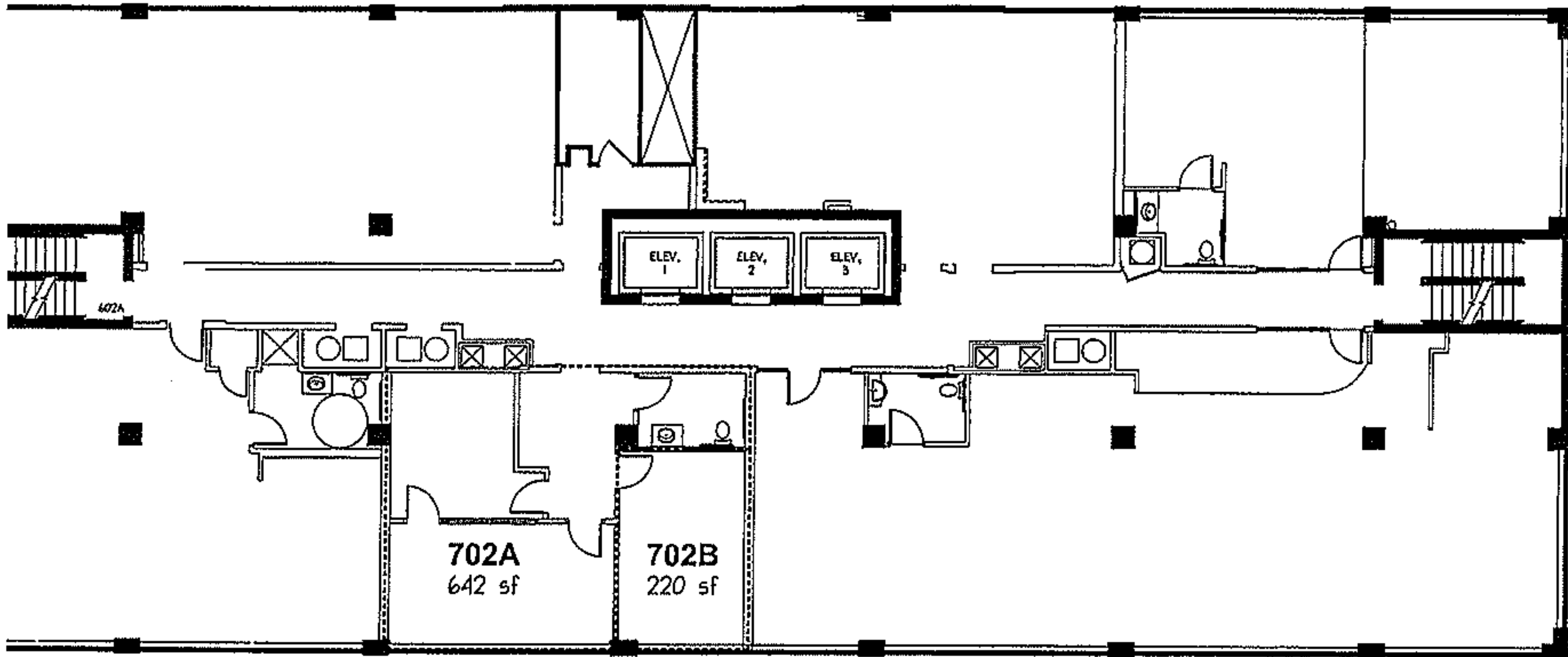

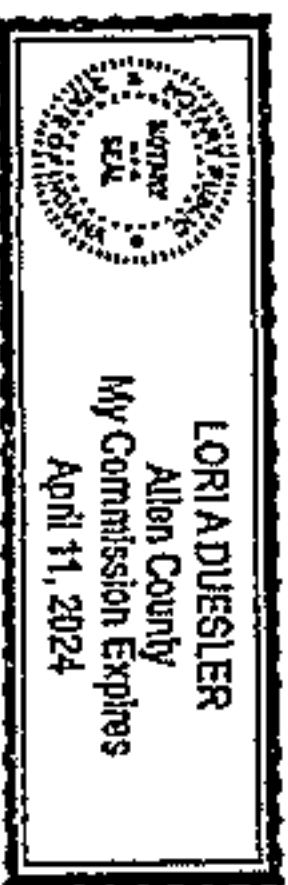
